

RULES & REGULATIONS:

- Howling at the moon, compulsory for all campers @ midnight
- Visitors entering Protea Hotel The Ranch and Kolobe Tented Camp – do so at their own risk
- Use of candles inside the tents is strictly forbidden – torches to be used in the event of a power failure
- Smoking inside the tents is prohibited
- Smokers are requested to use the red bins and not discard stompies in the natural bush due to the high risk of veld fires
- Motorbikes and 4 wheelers are strictly prohibited
- 4X4 vehicles may use the 4X4 track with prior management approval
- Camping is only allowed at the camp site and no private tents will be permitted
- No domestic pets allowed
- No littering will be tolerated – use bins provided
- Use water sparingly
- No walking and driving through the conservancy without a guide
- Only booked tours to the lion park will be allowed
- No firewood to be collected from the surrounding bush
- No harming, snaring, teasing or trying to catch the animals
- Removal of animals, birds, reptiles or any plant matter is strictly prohibited
- No firearms and weapons may be kept at the camp site, to be handed in for safekeeping at the main hotel
- Hunting and shooting is not permitted
- Fires only at designated spots
- Camp music must be switched off by 10pm then enjoy the natural sounds of the bush – management reserves the right to control the noise level.

INDEMNITY:

As the organiser of the group, I hereby acknowledge that I have read and fully understand the above information, rules and regulations.

I understand what is required of me in terms of payment and timing thereof in order to secure my chosen dates.

I understand no catering will be provided unless it has been previously arranged, menu and price agreed upon and the necessary payment made or official order submitted.

I will ensure that all campers will sign the indemnity form provided and release Protea Hotel The Ranch and The Kolobe Tented camp from any liability or assumption of risk that may result from our use of their facilities or whatever reason.

INDEMNITY FORM

hereby acknowledge that:

- I am aware of the dangers and inherent risks of illness, injury, death, loss & damage of property that may be involved in adventure travel.
- I understand it is my sole responsibility to insure myself and my property.
- I have been advised to obtain the necessary insurance that is commercially available to protect myself against accidental death & disability, major medical, emergency medical evacuation, loss of personal effects and trip cancellation.
- I understand the risks of the harsh wilderness habitat, the risk of malaria, the forces of nature and the dangers of my participation in outdoor activities – all of which are beyond the control of the owner.
- I recognise that such risk may be present at any time, before, during and after my arrival.
- I am aware that there is a swimming pool, jacuzzi, dams and other water features on the conservancy that may cause drowning.
- I understand the risks involved when viewing dangerous wild animals e.g. Lions
- I am further aware that medical services and facilities may not be readily available.

Taking all the above factors into consideration ... my signature below and by payment of my deposit and balance when due, indicates that I have accepted all of the above and release the owners, their agents and/or associates from Liability and Assumption of risk of my :

- Entering the property / conservancy / hotel premises
- Participating in any activities
- Using any services or facilities
- Eating or drinking any food / beverages arranged for me

I pledge not to sue the owners, their agents, associates, office members, suppliers and / or employees on account of any losses, claims, costs, liabilities or damages – and further, I agree not to claim the unenforceability of this agreement.

I agree the foregoing obligation shall be binding upon me personally as well as upon my heirs, executors, trustees, administrators and members of my family, and shall be binding upon any minders accompanying me.
